

Jason Structuring, Fixed Income, London, Class 2008

"Fixed Income Structuring is all about developing bespoke solutions to meet clients' needs. That means looking at complex derivatives that are based on more than one underlying asset - in my case interest-rate derivatives across all major European currencies and also US dollars. Part of the role is technical - understanding how the sophisticated models our quant teams have developed will behave - so you have to be comfortable with the analytics. But the other side is about client skills - being able to understand the clients' needs, their goals and their appetite for risk. We bring those two aspects together to come up with complex structured products that meet specific needs and which just aren't available anywhere else."

"Fundamentally innovation is what we do. There are a lot of plain vanilla products that clients can use, but when they need something different then it's up to us to figure out how to do it. We're dealing with tangible assets - power stations, toll roads, big infrastructure projects - to be financed off balance sheet so it's about creating special structures to achieve that, and doing the groundwork, the due diligence, and risk assessment to really understand what it is you're financing. And the fact is, a lot of what you are trying to do hasn't been done before - there's something about the underlying asset or the circumstances that make it unique, so you can't simply replicate what you did on the last deal. You have to come up with something new that suits the clients' purposes. You have to be able to work as a team and share ideas, to think laterally and to have a problem-solving mindset."

Angel Business Process Improvement, Operations, Hong Kong, Class 2008

"Having studied Risk Management Science at university, I targeted a firm that was serious about risk and BNP Paribas has risk management woven into its fabric; everyone has it in mind. My department works in two main areas - project management and 'kaizen'. We look at operations and workflows, analyse them from end to end to identify gaps and inefficiencies. I'm working on a system deployment across several territories at the moment, migrating from one system to another. The challenge is that the new system behaves differently so you have to check and validate everything, talk to the users and investigate discrepancies. You're also looking at how it interfaces with other systems to make sure that data carries across accurately. And then it's a question of volume - I'm looking at multiple territories and Hong Kong alone sees upwards of 10,000 transactions per month. We have to make sure they all complete smoothly."

Depending on which area you are applying for, our application and selection process is a combination of the following stages:

- Online application form
- Competency based questions (where applicable)
- Online tests (where applicable)
- Business interview or assessment centre

Minimum requirements

You'll need to have, or be on track to receive, a 2.1 degree (or regional equivalent) in any subject – though we view Maths, Economics, Sciences, Business, Engineering and Computer Science as the most relevant. We also have opportunities at Masters, PhD and MBA level in some business areas and locations.

You will need to be able to demonstrate good business English irrespective of which location you are applying for; other relevant languages may also be an advantage. Beyond this we are looking for you to demonstrate a real interest in finance and banking, intelligence, creativity and client focus – an understanding of the way our clients' needs and objectives drive everything we do.

Your application

Each stage of our selection process is designed to allow you to highlight your potential. To ensure you are fully prepared, we recommend you research our business in as much detail as you can and develop an understanding of the financial and banking world as a whole.

To give you the greatest chance of success, think about which roles and business areas best suit your experience, qualifications, personal skills and abilities, and highlight this 'fit' in your application.
